1. Applications are invited through online mode for recruitment to the post of **Hospital Administrators under the control of Director of Secondary Health (DSH) to work in Government Hospitals.**

The Candidates who have passed the MBBS Degree in foreign Universities, the 75% aggregate marks weightage is given as per the following formula.

In certain Foreign Universities Degrees shown as academic hours / amount of hours / ECIS Ranks / National Grade / Study hours / Credits / Grade points GPA/Pass etc., In such cases, where marks/ grades are not clearly shown, the Grade "C" with 50% as maximum marks will be awarded.

Marks awarded for languages shall not be considered for weightage of aggregate marks.

(3.5) If more than one applicant scores same marks, then the person with higher age will be assigned better rank.

(3.6) The carried forward vacancies are brought forward from previous recruitments. Selection/Appointment to such vacancies will be made first before the fresh vacancies.

**7. EQUIVALENT QUALIFICATION:**

At the time of verification of certificates, if it is noticed that any applicant who possesses a qualification other than requisite qualification and claims that said qualification is equivalent to the requisite qualification, the matter shall be referred to an 'Expert Committee' constituted by the APMSRB and the APMSRB will take a decision based on the report of the 'Expert Committee'.

- (9.2) Age relaxation for Ex-servicemen is applicable for those who have been released from armed forces other than by way of dismissal or discharge on account of misconduct or inefficiency.
- (9.3) Age relaxation for NCC Instructor: A person who was recruited as a whole-time Cadet Corps Instructor on or after the 1<sup>st</sup> January, 1963 on his discharge from the NCC either before or after expiry of the initial or extended tenure of his office in NCC having served for a period of not less than six months prior to his release from the NCC.

## 12. PROCEDURE FOR APPLICATION:

- (12.1) Application has to be submitted online on APMSRB website (<https://apmsrb.ap.gov.in/msrb>) only.
- (12.2) Applicants should upload all required certificates (original certificates have to be uploaded for verification at the time of scrutiny before finalizing the selection list).
- (12.3) Applications once submitted online shall be final and no changes shall be permitted thereafter.
- (12.4) Upon submission of online form, Notification wise Application Number will be generated. The same may be used for any future reference.
- (12.5) Applicant must compulsorily fill-up all relevant columns of the application form carefully.
- (12.6) Incomplete / incorrect application form will be rejected. The information if any furnished by the applicant subsequently in any form will not be entertained by the APMSRB under any circumstances.
- (12.7) The applicant should not furnish any particulars that are false, tampered, fabricated, or suppress any material information while submitting online application. The applicant shall be liable for legal action in such cases.

## 13. RESERVATIONS: -

- (13.1) The Rule of Reservation is applicable as issued by state government from time to time.
- (13.2) Horizontal reservations for women will be followed in this recruitment, in terms of G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023.
- (13.3) The Reservation of 3 % for 'Meritorious Sports Persons' is applicable as per the amendments made to State and Subordinate Service Rules (G.O.Ms.No.77 General Administration (Ser.D) Department Dated: 02.08.2023 and **Go Ms. No.4 YOUTH ADVANCEMENT, TOURISM & CULTURE (SPORTS & YOUTH SERVICES) Dept., Dated: 19.04.2025** or as may be revised by the government from time to time. The proforma for obtaining sports certificates are given at Annexure III. Certificates which are not in the prescribed proforma will not be accepted.
- (13.4) Economically Weaker Sections: The EWS reservation is applicable as per G.O.Ms.No.24 General Administration (CABINET-II) Dept., Dt.23/02/2023 and G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023.
- (13.5) Reservation for benchmark disabilities:
- (13.5.1) As per G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023, the posts notified herein are exempt from the following

benchmark disabilities:

- (i) Blindness and low vision
  - (ii) Deaf and hard of hearing
  - (iii) Autism, Intellectual Disability, Specific Learning Disability and Mental Illness
  - (iv) Multiple Disabilities
- (13.5.2) Providing 4% reservation for persons with locomotor disability (a type of benchmark disability) is mandated by Section 34(1) of India's Rights of Persons with Disabilities Act, 2016, which requires appropriate governments to reserve not less than four percent of total vacancies in government establishments for persons with benchmark disabilities, including locomotor disabilities. This reservation applies to the total number of vacancies in a cadre, whether the posts are identified for people with disabilities or not.
- (13.5.3) Physically Challenged applicants who are claiming reservations under disability quota must note that they will be referred to State Medical Board (Appellate Medical Authority) after completion of certificate verification. The report of the Medical Board is final.
- (13.5.4) Guidelines for evaluation of various disabilities and procedure for certification are mentioned in G.O.Ms.No.31, WD, CW & (DW) Dept, Dt:01- 12-2009.

(13.6) In terms of G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023, Two percent 2% reservation shall be provided to Ex-Servicemen(Doctors) in direct recruitment. Out of two percent (2%), one percent of posts shall be given to women and if no women Ex-servicemen candidate is available, two percent (2%) of reservation shall be filled up with men. who served in armed forces on temporary basis.

#### 14. COMMUNITY CERTIFICATE:

(14.1) Applicants belonging to ST are required to produce Community Certificate issued by the competent authority of Government of Andhra Pradesh.

(14.2) Applicants belonging to Schedule Classes are required to produce Community Certificate (SC-I, SC-II and SC-III) issued by the Competent Authority of Government of Andhra Pradesh Read Go.Ms.No.46, General Administration (Ser-D) Dept., Dated: 19.04.2005 and G.O. Ms No.7, Social Welfare (CV) Dept., Dated: 18.04.2025.  
**NOTE:** SC Sub-classification is applicable. SC applicants must clearly specify their Group: SC (Group-I), SC (Group-II) or SC (Group-III)

(14.3) Applicants belonging to Backward Classes are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D & BC-E) issued by the Competent Authority of Government of Andhra Pradesh

(14.4) Applicants belonging to Economically Weaker Section (EWS) for claiming EWS Reservation should produce "Income & Asset Certificate" issued by competent authority of Government of Andhra Pradesh for **current financial year** i.e., 2026-27

(14.5) Certificates issued by competent authorities of Government of Andhra Pradesh will only be considered.

(14.6) Applicants belonging to states other than Andhra Pradesh are not entitled to any kind of reservation.

#### 15. RESERVATION TO LOCAL CANDIDATES

### (15.1) LOCAL CANDIDATURE

- Candidates who are Local to Andhra Pradesh are only eligible for the posts reserved for local category. (Candidates who studied from 4th Class to 10th Class in the State of Andhra Pradesh and candidates who migrated to any part of Andhra Pradesh from the State of Telangana within a period of 3 years from 2<sup>nd</sup> June 2014. (As per G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016) are considered as Local).
- The Residence Certificate/Nativity/Domicile Certificate issued by MRO/ Tahsildar will not be allowed for Local consideration without mentioning the G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016 for the candidate who studied in the state of Telangana before bifurcation.
- "Local Candidate" means a candidate for direct recruitment to any of the post in relation to those Local areas where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.

(15.2) Residence certificate will not be accepted, if a candidate who studied in any Educational institutions up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.

### 16.GENERAL PROVISIONS

(16.1) Required original certificates should be submitted at the time of verification of certificates or whenever called for. Failure to produce the required certificates will lead to disqualification.

**(16.2) Important:** The claim of the applicants with regard to the date of birth, educational qualifications and community etc., are accepted provisionally on the basis of information furnished by them in their application form and is subject to verification and satisfaction of the APMSRB. Mere inclusion of the name of an applicant in a Merit List will not confer on the applicant any right for appointment. The candidature is therefore, provisional at all stages and the APMSRB reserves the right to reject candidature at any stage of the selection even after declaration of results, if any mistake is noticed at a later date.

17. Printout of downloaded application form as well as original certificates /documents as mentioned at Para (5) have to be submitted at the time of certificate verification.

### 18. DEBARMENT:

(18.1) Candidates should make sure of their eligibility to the posts applied for and that the declaration made by them in the application form regarding their eligibility is correct in all respects. Any candidate furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the APMSRB, and for summary rejection of candidature for this recruitment & further recruitment.

(18.2) The Board is vested with the duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such matter or such action as to violate or is likely to violate fair practices followed and ensured by the Board

will be sufficient cause for rendering such questionable means ground for APMSRB.

### **19. Board decision to be final:**

(19.1) The decision of the department regarding acceptance or rejection of the candidature, conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

(19.2) All desirous and eligible candidates shall apply online after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent through any mode other than the prescribed online mode will not be entertained under any circumstances. Submission of application form by the candidate is authentication that he/she has read the notification and shall abide by the terms and conditions laid down there under.
