**Terms and Conditions for applying for the Panel Advocate for Land
Acquisition, Rehabilitation and Resettlement Authority, Nashik
Part-A**

1. The Applicant should be practising advocate and should have at least 10 years experience of conducting in Civil, Criminal, Labour and Industrial, Service matters, as the case may be as on 31/03/2026 (However seniority in the profession will be counted as an addition). Applicant should have completed age 35 years as on 31/03/2026.
2. Applicant shall have knowledge and skill of communication of E-mail/internet /computerised system.
3. Every applicant shall submit a non-refundable Demand Draft of **Rs.100/-** in favour of Superintending Engineer, DIPC,Dhule drawn on Bank of Maharashtra,Dhule. Envelopes with postage stamp of Rs.30 should be submitted along with the application stating full name and mailing address of applicant
4. Applicant shall be interviewed by a committee formed under the direction by the Superintending Engineer, DIPC,Dhule
5. The period of Appointment on panel shall be 2 years initially and may be extended at the discretion of TIDC/Superintending Engineer, DIPC,Dhule
6. **A.** Appointed as Govt.Pleader/Additional Govt.Pleader /Asst. Govt. Pleader shall be treated as disqualification for appointment and working on the Panel of Superintending Engineer, DIPC,Dhule
B. Applicant shall submit security deposit of an account payee Demand Draft of Rs.10,000/- (Rs.Ten Thousand only) in favour of Superintending Engineer, DIPC,Dhule payable at Bank of Maharashtra,Dhule at the time of joining.
7. Applicant shall have to appear before Interview Committee formed by Superintending Engineer, DIPC,Dhule
8. Interview shall be for 50 marks. Applicant securing less than 50% marks (below 25 marks) shall not be selected.
9. i] No TA/DA or any other expenses shall be admissible or honored, to the panel advocate opts to work in local Court /authority at Nashik and outstation any other Courts.
ii] He shall give in writing consent to DIPC that he is ready to work without TA/DA

10. Applicant shall not have been debarred from practising as an advocate for any period by Competant Authority.
11. Superintending Engineer, DIPC,Dhule reserves its rights not to call any applicant for interview without assigning any reasons.
12. Canvassing for selection of the applicant in any way shall debar him from process of selection.
13. Incomplete application shall be rejected.

Part- B

14. Eligible and suitable applicants will be informed by Email or by post, the place, date and time of interview and will have to appear before Interview Committee of Superintending Engineer, DIPC,Dhule for assessing his suitability or otherwise for panel advocate at his own expences.
15. Applicant Advocate will have to appear on the appointed day and time with his/her own expenses before the interview committee along with original certificates regarding his educational qualifications, 'Sanad' issued by the Bar Council of Maharashtra and Goa, certificate showing his age and experience of standing practice issued by the Registrar of the Hon'ble District Court or President of Bar Association District Court, or Local Bar Association, where he is practising.
16. The interview committee of Superintending Engineer, DIPC,Dhule shall assess the Legal and general knowledge and experience, skill of presentation for the suitability and over all performance or otherwise of the applicant candidate for selection on merit.
17. The decision of TIDC/Superintending Engineer, DIPC,Dhule. shall be final in the selection matter.
18. Selected Applicant Advocates will have to execute consent letter about terms and conditions in favour of Superintending Engineer, DIPC,Dhule.
19. Reasons for selection or non selection shall not be intimated/ communicated to anybody.
20. No correspondence from applicants in this respect shall be entertained.
