Section 18(7) and (8) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not less than **seven years** may be appointed as **Public Prosecutor** or an **Additional Public Prosecutor** and not less than **ten years** may be appointed as **Special Public Prosecutor**.

The law officer will be appointed on tenure basis for the period to be prescribed by the Government. The appointment of above posts may be terminated by the Government before the expiry of term. In respect of the appointment of Law Officers and the number of vacancies to be filled, the decision of the Government shall be final.


The advocates in Tamil Nadu with not less than Seven years/Ten years of standing at the Bar, who are willing to accept the post are requested to express their willingness in writing to the undersigned by furnishing the particulars required in the prescribed application form **Annexure I & II** in **six copies** with **two passport size photographs**. The application should reach this office on or before **02.07.2026, 05:45 PM**

The application received after 5.45 P.M on 02.07.2026 will not be considered and it will be summarily rejected.
